2017 National Report Reminder

Pinpointing these hotspots and addressing concerns well in advance of our annual deadlines will help decrease the burden of completing CARES forms by our deadlines. CARES staff will release this year's National Report in April of 2018. As a reminder, participating EMS agencies should enter all 2017 records by January 31, 2018 and hospitals should complete data entry by February 28, 2018. Software Update

CARES released a software update in July, to include the following enhancements:

- CARES deployed an update to all hospital users' Dashboards, by adding a column for "Transferred: (Yes/No)". When hospital users log-in to CARES, they'll now be able to see whether each patient was transported directly to their hospital by EMS (Transferred = No), or transferred from another acute care facility (Transferred = Yes).
- Narcan was added as an answer choice to #42 "Were drugs administered".
- Call Volume by Month/Week Dashboard bar graphs were expanded from 8 to 12 months/weeks for optimized viewing of data.
